### Water, Sewer, and Garbage:

Morgan reported that the power was out six hours Sunday night and generator at the sewer plant handled the situation just fine. There were a lot of branches that came down in the storm. Dave Lourie from Test, Inc. had previously mentioned that he was amazed on how clean the water was at the sewer plant.

### Economic Development:

Motion by Brinkmeier to approve Jody Mertz's Beautification Project request for reimbursement with receipts totaling \$347.20. Second by Morgan. Roll Call.

Citizen's Comments: The main goal of the Village was to eliminate holes in the alley. Right now the alleys are 10 feet wide and the county's equipment is 13 feet wide. Residents are worried how the alleys will hold up once they are plowed this winter. They will have to be plowed straight with the blade up a little. Residents need to discuss whether losing 1 1/2 feet on either side will be acceptable to them.

Public Works Superintendent Mark Hinrichs reported that they had dug out gravel, put dirt in a low spot at the back of Village Hall property by the alley, had a favorable EPA water inspection, sheet metal is being installed on the Maintenance Building roof, took meter out of Well 3 and shipped off to MN for maintenance, and the Lions Club will use a generator for the ball games on July 16th and 17th.

Attorney Mitchell gave Meiste the filed copy of Ordinance 584. He also recorded the 2018/2019 Levy amount of \$79,000 with the county.

Kim handed out Thomson's ATV/UTF/Golf Cart Ordinance to the trustees to view before the next committee meeting.
